NOTICE n. 00010/2016/DIREAGU/EAGU/AGU

This notice opens public call and regulates the requirements and basis for cooperation agreements between Escola da AGU (School of AGU) and Foreign Universities.

THE DIRECTOR OF ESCOLA DA ADVOCACIA-GERAL DA UNIÃO MINISTRO VICTOR NUNES LEAL (Attorney General School Ministro Victor Nunes Leal), vested by the powers issued by items I e IV, article 7 of Portaria AGU n. 134 (issued April, 9th, 2012), and considering the need to give wide publicity, transparency and regulate possible cooperation agreements between Escola da Advocacia-Geral da União Ministro Victor Nunes Leal and foreign Universities, states:

Art. 1. Escola da Advocacia-Geral da União Ministro Victor Nunes Leal, herein simply Escola da AGU, expresses the intent to sign cooperation agreements with foreign Universities classified among the 400 best Universities in the world for Social Sciences, according to *QS World University Rankings*, or that are better ranked than one of those Universities according to another ranking considering exclusively Law Schools.

§1. Escola da AGU may celebrate cooperation agreement with foreign Universities not fulfilling the requirements above, if:

I – Escola da AGU technically recognizes the suitability of the University and the existence of scientific and institutional interest in celebrating the respective cooperation agreement; and

II – Escola da AGU Advisory Board approves the technical opinion mentioned in the previous item, as well as the terms of the cooperation agreement.

§2. For the purpose of measuring the classification of the University in any ranking, it will be considered the last available evaluation considering the date of the cooperation agreement signature or, if that is the case, of the respective extension.

§3 For the conclusion of the agreement purposes, the Universities should contact the Coordination of Technical Assistance (Coordenação da Assessoria Técnica) of Escola da AGU,

by *e-mail* eagu.assesstecnica@agu.gov.br or phone numbers +55 61 2026- 7980 /7386. The University concerned should send a written expression of interest in signing the agreement as well as documentation showing its classification according to art. 1º, *caput*.

Art. 2. The Cooperation Agreements based in this notice terms will be drawn up by both Escola da AGU and the University concerned and will state:

I – Concerning its object, considering other relevant aspects:

- a) the possibility of participation of AGU officers in research programs, specialization courses, Master, PhD., observed the requirements of selection and admission of each University; and
- b) the possibility of participation of teachers, lecturers, professors and/or students of the University in research programs and courses promoted by AGU, subject to the conditions and possibilities of the AGU.

II – Concerning the implementation:

- a) provision that the cooperation agreement will not involve any financial outlay between the parties;
- b) University representative indication to act as a focal point with the Escola da AGU, in order to facilitate the negotiations and communication between the parties.

III – Concerning the duration, it will be up to 30 (thirty) months from the date of signature; it may be extended by an amendment up to sixty (60) months.

Art. 3. For the purpose of giving more publicity and transparency to this notice, Escola da AGU will keep it permanently available for consultation on its website in the original version, as well as in English and Spanish.

Sole paragraph. Any questions about the terms of this notice will be clarified by the Director of Escola da AGU.

Art. 4 All cooperation agreements already in force are recognized as valid. Their extensions, however, must follow the terms of this notice.

Art. 5 This notice is valid indefinitely.
